SHORTLY AFTER RECEIPT, YOU WILL RECEIVE AN ACKNOWLEDGMENT THAT YOUR NOMINATING STATEMENT HAS BEEN RECEIVED. IF YOU DO NOT RECEIVE SUCH AN ACKNOWLEDGMENT WITHIN 48 HOURS AFTER YOU SUBMIT IT, YOU MUST CONTACT THE CHAIR OF THE NOMINATING COMMITTEE.
